David Campbell was appointed Consul General Frankfurt and Senior Trade and Investment Commissioner, West Europe in February 2013. He manages a network of offices in major European markets and is responsible for attracting European businesses to establish operations in Australia, promoting Australia as a study destination and assisting Australian companies to enter the European market. In addition his consular team provides services to the southern regions of Germany. David joined Austrade from the financial services industry with more than 18 years of experience in Australasian and UK/European markets. Originally a lawyer, he has held numerous senior business development roles in the wholesale and investment banking sectors. Most recently David was a Managing Director with UBS where he managed the Melbourne office of the global Wealth Management business and was a member of the Australian Executive Committee.



Nick Dawson is head of Bilfinger's global asset management business, with operations in Australia, North America, UK and Continental Europe. The business is responsible for a wide variety of assets from major highways, tunnels and bridges, through to schools, hospitals, prisons, and commercial real estate. Nick has worked for Bilfinger for more than 12 years, previously as head of its global PPP business, which invested substantially in Australian public infrastructure. Nick's background is in civil engineering, and he has lived and worked in many countries. He spent five years in Australia in the eighties managing the construction of the North West Shelf gas project for Woodside Petroleum.



Frank Dornseifer is Managing Director of Bundesverband Alternative Investments e.V., the German lobby organization for the Alternative Investment industry. He studied law at the universities of Bonn, Dublin (Trinity College) and Lausanne. After admission to the German Bar in 2000 he practised various years as attorney in an international law firm in the field of corporate and securities law before joining the German Financial Regulator BaFin as deputy head of the policy unit within the investment management department. In this function he also represented BaFin in the Investment Management Committee of IOSCO. Mr. Dornseifer frequently publishes articles both on investment and corporate law and he is co-editor of legal commentaries on the German Investment Act and on the AIFM Directive. The finance committee of the German Bundestag, the EU commission and the European Parliament denominated him several times as expert on capital market law. Mr. Dornseifer gives frequently speeches at national and international conferences on investment and regulatory topics.



Philippe Taillardat is a partner of Direct Infrastructure for CFSGAM / First State Investments based in Europe. In his role, Philippe is primarily responsible for portfolio management, client interface, and contributes his experience to investment decisions. Prior to joining FSI in September 2011, Philippe was Co-Founder of Oaksley Conseil, an advisory company providing investment solutions to institutional investors and asset management platforms in the energy and infrastructure sectors. He was previously Managing Director at Amundi Private Equity Funds for three years, where he was responsible for the infrastructure fund selection. Before that, Philippe held various roles at Calyon CIB, AXA, Credit Suisse Group and BNP Paribas. In total, Philippe has 21 years' experience in energy, infrastructure and other industrial sectors, including principal investing, financial advisory, equity and debt financing. Philippe holds a Master in Business Administration from EMLYON Business School, and an MS in Mechanical Engineering from Arts et Métiers ParisTech with a major in Industrial System Management.
